## ORDINANCE NO. 20220920D

AN ORDINANCE AMENDING THE SANITATION RATE ORDINANCE OF THE CITY OF KRESS AND REPEALING ALL PRIOR INCONSISTENT ORDINANCES:

WHEREAS, it has become necessary and desirable to revise the rates for sanitation service supplied by the City of Kress to customers in order to both provide reasonable compensation to the City of Kress therefor and provide sanitation service at reasonable rates to customers of the City of Kress; and

WHEREAS, the rates hereinafter set out have, after investigations by the City Council of the City of Kress, been found to be fair and reasonable.

NOW, THEREFOR, be it ordained by the City Council of the City of Kress, Kress, Texas: sanitation rates

## **ARTICLE 1 SANITATION RATES**

## SECTION 1-1 Sanitation (trash pickup).

(1) <u>Domestic residential customers</u>. The following monthly garbage collection and removal rate shall apply to all domestic residential customers within the corporate limits of the city, for one (1) pickup per week:

Monthly charge: \$28.98

(2) <u>Apartments, multiple-family units and mobile home units</u>. The following monthly garbage collection and removal rate shall apply to each apartment unit, multiple-family unit, or mobile home space where the [apartment, multiple-family development or mobile home park is on a master] meter for water consumption with the city, for one (1) pickup per week:

Monthly charge: \$28.98 per unit occupied.

(3) <u>Domestic commercial customers</u>. The following monthly garbage collection and removal rate shall apply to all domestic commercial customers within the corporate limits of the city, for one (1) pickup per week:

Monthly charge: \$51.98 EACH

When more than one pickup per week is requested or scheduled by the customer, the rate per container shall multiply by the number of pickups scheduled.

(4) <u>Senior Citizen age 65:</u> The following monthly garbage collection and removal rate shall apply to all domestic commercial customers within the corporate limits of the city, for one (1) pickup per week:

Monthly charge: \$28.98

- (5) Schools Monthly Flat Rate: \$926.20
- (6) Residential rates for city employee, Volunteer Fire Dept, City Council, Mayor

Monthly Rate \$4.50

(7) <u>Taxes and other fees</u>. Sanitation (garbage pickup) service is subject to state, county and local sales tax per the contractor. The city bills for and collects the tax for the contractor per the contractor. This charge for sales tax is subject to change.

## SECTION 1-2 EFFECTIVE DATE

This Ordinance shall take effect from and after its passage and publication as required by law.
